With this in mind , I made a few phone calls; I was directed to Phil Acre of LADOT who on two days notice, kindly consented to speak at the FHRA meeting.

He informed us that a restructuring study was made to adjust MTA and the existing LADOT to create a Franklin Hills Los Feliz DASH. Every year money from MTA funds new transit projects. The funding for the DASH vehicles were ranked by community in order of need. There were 29 projects funded. We were thirtieth. We will have to wait another year until new applications are again accepted. I do not think we should have to wait that long. We should have some form of transportation to the subway – period.

Vince Rossini, Councilman John Ferraro's representative for this area, suggested we send a letter to Councilman Ferraro stating how we feel about this situation, and that we want a shuttle. After all, if we do not raise a bit of a ruckus, we will have nothing – squeaky wheel and all that!
